



CALL FOR BIDS:

PURCHASE OF ONE (1) NEW 4WD WITH REGULAR CAB & HYDRAULIC DUMP BOX

The Town of Harbour Grace is calling for bids for the **purchase, supply, and delivery of one (1) new 4WD with regular cab and hydraulic dump box.**

General Specifications:

- 2024 – D5500 – F550 or equivalent
- C/W electric/hydraulic 11' dump box with canopy and tailgate
- Truck shall be single cab and grey in colour
- Truck shall be 4x4 with limited slip rear differential
- Minimum 19,500 gross vehicle weight rating
- Front axle 7,000 lbs
- Rear axle 13,500 lbs with dual wheels
- Minimum 6.9 litre diesel engine with minimum 330 HP 850 ft lbs torque
- Engine block heater, 300-amp alternator – 730-amp maintenance-free battery
- 10-speed automatic transmission with backup alarm
- Vinyl seats – rubber flooring/rubber floor mat (no carpet)
- 19.5" x 6" steel wheels
- 225/70R19.5G all-position traction tires (6)
- Full size spare tire mounted on rim
- Two (2) rib type front tires (summer) mounted on steel rims
- Heated mirrors
- Power window and power door locks
- Dual note horn
- Sliding rear window
- Maximum tow pkg – installed
- PWR accessory group
- Electronic monitoring module
- Transfer case skid plate
- Tubular side steps
- Vehicle shall be rust-checked or equivalent
- Vehicle shall have DOT roadside safety kit (ie., fire extinguisher, first aid kit, safety flares, etc.)
- Eleven- (11-) foot hydraulic dump with fold down sides
- Body to be equipped with two (2) pairs of mud flaps and anti-sail brackets
- Two (2) work lights placed at rear of dump box
- Blue flashing lights installed in rear of dump box
- Bidder shall provide two (2) parts books, two (2) service and repair manuals, plus two (2) Operator's Manuals for all components of vehicle
- Warranty: Basic – three (3) years/60,000 km; Drive-train – five (5) years/100,000 km; Turbo diesel – five (5) years/160,000 km; Corrosion – three (3) years/unlimited km; Roadside assistance – 5 years/100,000 km.

The unit offered shall be new, of the latest design, and in current production. The bidder must be able to supply the unit by November, 2024.

Individual bids must be clearly marked: "Bid for Purchase of New Town of Harbour Grace 4WD with Regular Cab & Hydraulic Dump Box."

Sealed bids will be accepted at the Town Hall, 112 Water Street, Harbour Grace, NL, until 12:30 p.m. on Wednesday, February 28, 2024, when they will be opened publicly.
